The board reviewed the Open Enrollment (OE) information provided and discussed OE space limits for the 2023-24 school year. Planning is now beginning for the 2023 summer school programming. The plan will be to run 2 sections, pending enough staff, 4 days a week for 3 weeks.

The board reviewed and discussed the WASB School Board School Perceptions Board Development Tool all board members and administration completed.

Motion by Vesely, 2nd by Seubert to approve Connor Ellenbecker as summer school principal. Yes- Klumpyan, Knoeck, Seubert, Vesely and DeBroux. Motion carried 5-0.

The board reviewed WASB Delegate Assembly Resolutions. Beth Seubert will replace Lia Klumpyan as the representative at the convention.

Mr. Beranek informed the board outside group counseling with parent permission will be starting. The YRBS survey will be given next week, and Mike McGowen will continue his presentation with schools on February 8th. ACT prep days will be held in late February with the ACT test given on March 7th. Mrs. Sternberg will be volunteering to organize a High School Chess Club.

Mr. McCain reviewed the success of the Holiday Concerts, 5th Grade DARE Graduation, and the upcoming Spelling Bee. The 5th grade will be attending James & Giant Peach. And, interviews were held for the Multilingual Learners position.

Mr. Parks shared concerns about use of the Wellness Center access and the upcoming staff Holiday gathering. A land detachment petition will be on the February agenda for consideration.

Motion by Klumpyan, 2nd by Vesely to go into closed session pursuant to State Statute 19.85(1)(c) and (f) to consider employment, promotion, compensation, or performance of any public employee over which the governmental body has jurisdiction or exercises

responsibility; and, deliberating and conducting other specified business whenever competitive or bargaining reasons require a closed session.
