Motion by Knoeck, 2nd by Seubert to adjust the 2023-24 student space limit caps to 8 for 4K and 2 for 5th grade. Yes – Klumpyan, Knoeck, Seubert, DeBroux and Vesely. Motion carried 5-0

Motion by Klumpyan, 2nd by Vesely to increase the high school activity fee to \$30 per student, with a \$60 family camp, and rescind the student fee for high school students. Yes – DeBroux, Klumpyan, Knoeck, Seubert, and Vesely. Motion carried 5-0.

Motion by Knoeck, 2nd by Seubert to approve the Intergovernmental Agreement between Edgar School District and School District of Marathon City, 66.0301 Intergovernmental Agreement for purchase of High School Art Teaching Services. Yes – Klumpyan, Knoeck, Seubert, Vesely and DeBroux. Motion carried 5-0.

Motion by Vesely, 2nd by Seubert to approve the 2nd reading of the NEOLA policy updates Volume 32 No. 1 with the exception of a requested change in wording of the Athletic Code. The Athletic Code will be brought back in July for approval. Motion carried.

A general discussion was held regarding communications with the school district that are shared with school families pertaining to non-profit organizations and fund-raising. The discussion included a request by Harvest Your Zen (HYZ) for a letter of support in their non-profit's effort to apply for a Community Foundation grant.

The board set the meeting date of June 28, 7:30AM as a special meeting for 2023-24 proposed budget review.

Motion by Seubert, 2nd by Klumpyan to hire Cassandra Stocker as Multilingual teacher. Yes – DeBroux, Klumpyan, Knoeck, Seubert, and Vesely. Motion carried 5-0.

Motion by Klumpyan, 2nd by Seubert to hire Jacob Skalitzky as High School Social Studies Teacher. Yes – DeBroux, Klumpyan, Knoeck, Seubert, and Vesely. Motion carried 5-0.

Motion by Knoeck, 2nd by Vesely to hire Jayci Blume and Ryan Whalen as MAES/MVA PE Teachers. Yes – DeBroux, Klumpyan, Knoeck, Seubert, and Vesely. Motion carried 5-0.

Motion by Seubert, 2nd by Vesely to table the hiring of the MVA Science Teacher. Motion carried.

Motion by Knoeck, 2nd by Seubert to table the Expeditionary Learning service contracts for MAES and MVA until the June 28, 2023 special meeting. Motion carried.

Information was shared regarding the co-curricular contracts, including a presentation regarding expanding the dance team/spirit squad with a decision at a future meeting. Motion by Klumpyan, 2nd by Vesely to approve the MAES/MVA 2023-24 Co-Curricular contracts as presented. Yes – DeBroux, Klumpyan, Knoeck, Seubert, and Vesely. Motion carried 5-0.

Motion by Knoeck, 2nd by Vesely to approve the 2023 Fall Coaching contracts with the exception of the head cross country position which will be posted as an opening in-house prior to approval. Yes – DeBroux, Klumpyan, Knoeck, Seubert, and Vesely. Motion carried 5-0.

A Spring Sport review by Mr. Miller was presented.

Mr. Parks updated the board on the Marawood continuing to have golf as a conference sport, but prorating the number of medalists based on the number of participating Marawood teams. The Conference is also looking into Go Fan, an online ticket sales vendor, as a possible recommendation within the conference in upcoming months.

Mr. McCain updated the board on summer school, 2023-24 school year planning, and end of year activities.

Mr. Beranek gave an update on the 2nd place WIAA State Track team award, and the current teaching position vacancies at the high school.

Mr. Parks reported on the Memorandum of Understanding with the Medical Advisor, Wellness Center summer hours, Medicaid payments to the district, and CWETN bylaw changes. A Defeasance report document was shared noting a savings to taxpayers of approximately \$471,000 in interest, signatures will be needed when the original documents are delivered. A thank you was given to Mr. McCain for his years with the district.

Motion by Vesely, 2nd by Seubert to adjourn. Motion carried. Meeting adjourned at 8:24 PM.
